Compensation: \$10/hour



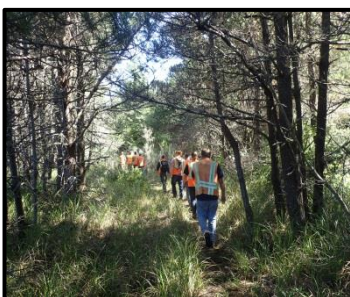
Essential Responsibilities (to include, but not limited to):

- Riparian restoration activities
 - Invasive plant removal
 - Fence construction
 - Erosion control
- Native plants
 - Rare plant surveys
 - Plant nursery maintenance (weeding, watering, raised bed construction, etc.)
- Trail maintenance on Bureau of Land Management recreation sites (North Spit, New River, Bastendorff)
- Working with local natural resource professionals to learn about career opportunities



Position Requirements:

- Ability to work long days (10 hours) in all types of weather (sun, wind, rain, heat)
 - **Schedule: Monday-Thursday, 7am-5:30pm**
- Reliable transportation: the Crew leaves Coos Bay Fred Meyer at **7 am** & returns at **5:30 pm**
- Strong incentive to learn how to safely operate equipment (weed whacker, DR mower, hand tools)
- Positive attitude & comfortable working on a team
