
2024 Teddy Villers Natural Resources Scholarship




The Coos Watershed Association and the Villers Family of the Blue Ridge Timber Company will offer a scholarship of \$3,000 to a student planning to pursue a degree or certificate in an environmental/ natural science field from an accredited institution of higher learning. This scholarship honors the life of Teddy Villers, son of Mark and Adela Villers, who lost his life while working on a salmon habitat restoration project with his dad in September 2015. Teddy had a strong curiosity for the natural world and loved working with his dad in the woods. The Coos Watershed Association and Villers Family will award this scholarship to a candidate who demonstrates a passion for and commitment to studying natural sciences. Applicants must meet all three of the following criteria to be eligible for consideration:

- Must be a current high school senior or community college student (or recent graduate)
- Must currently reside in, or attend/plan to attend school in, the Coos watershed geographical area (Coos Bay, North Bend, Charleston, Allegany, or surrounding areas; see map). Students who live in other parts of Coos County (Coquille, Myrtle Point, Powers, etc.) and who plan to attend college at Southwestern Oregon Community College may apply.
